# <u>般條款 MAIN</u> TERMS

本合約由智尚商務國際有限公司(服務供應商)提供,並由申請虛擬辦公室服務的公司或個人(客戶)同意,雙方共同履行合約內所載 的條款及細則。

This agreement is offered by Brilliant Business Centre Limited (Service provider) and is accepted by the applicant of virtual office service (Customer), both executing those terms and conditions stated in this agreement.

This agreement shall be governed by and construed in accordance with the laws of the Hong Kong Special Administrative Region ("HKSAR") and the parties hereby irrevocably submit to the non-exclusive jurisdiction of the Courts of the HKSAR.
